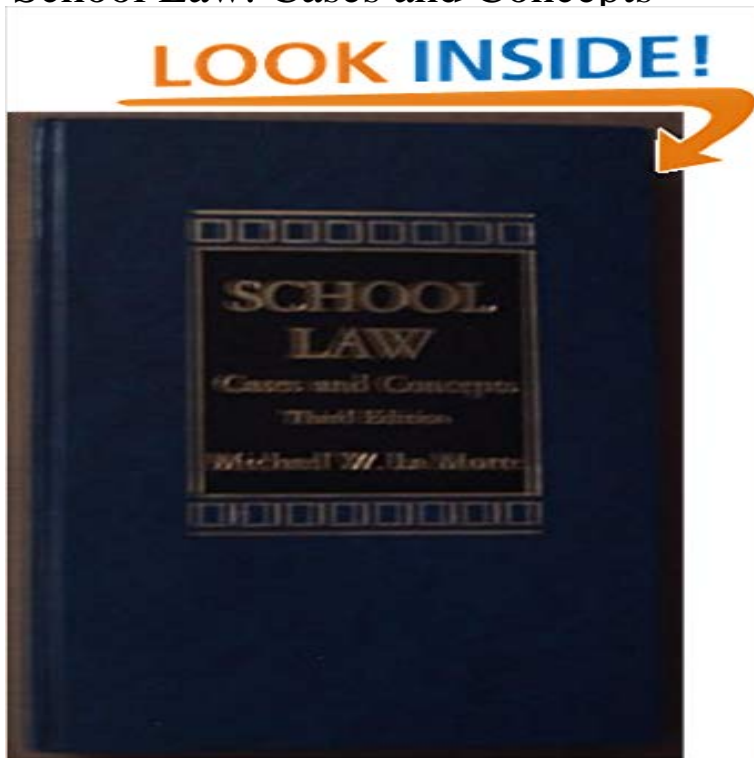


## School Law: Cases and Concepts
