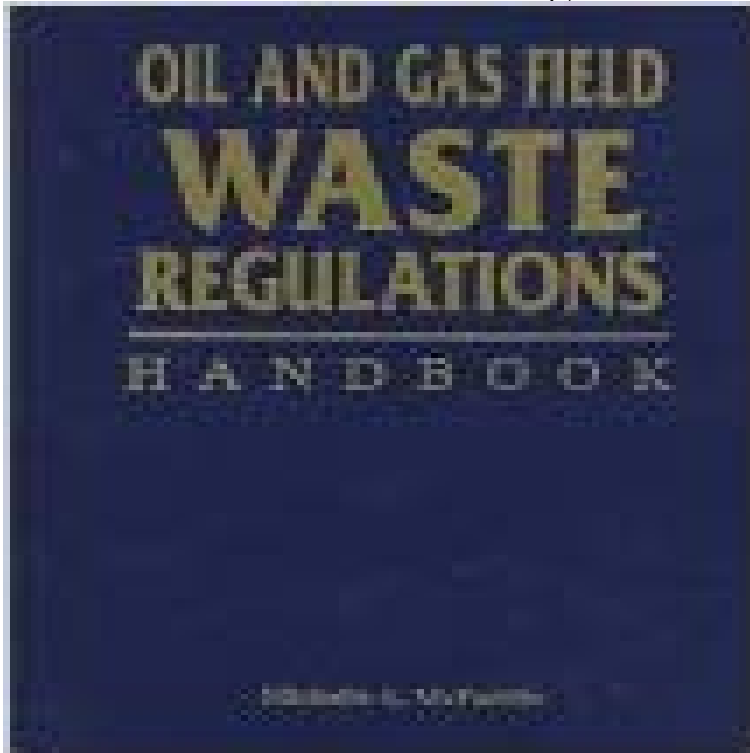


Oil and Gas Field Waste Regulations Handbook
